# Welcome to Tax Season 2020:

#### New Items this year to talk about :)

- 1. <u>Charity deduction of \$300</u> (cash and checks only) to be added to the standard deduction amount (if not using Sch A deductions)
- <u>IRA deferral withdraws</u> for 2020 will not have to be taken in 2021, IRA withdrawals will have a choice to have it taxed in 2020 or do a <u>3 year</u> <u>averaging</u> on the amount withdrawn Form 8915-E
- 3. <u>RMD</u> from Pensions/IRA <u>age limit has increased to 72.5</u> and a new chart is available :)
- 4. <u>Medical cap 7.5% AGI</u> deduction has been extended for 2020 (this will increase to 10% in 2021) Most tax payers do not use the Schedule A since 2018
- <u>IRA and HSA's have 4-15-21 deadlines</u> for contributions— IRA contributions plus W-2 deferred amounts can not exceed \$19500 in 2020 and are subject to AGI under \$75,000. <u>HSA's in 2020</u> contributions (Single \$3550 with \$1000 make up over age 55, Family \$7100 with make up according to account holders age of 55)
- 6. <u>Energy Credit is still available</u> if you have not used all or any of the \$500 credit Form 5695 is still available for Windows-Doors-Roofs-Furnaces-Other energy savings (Not appliances)

- 01/31 W-2's and 1099's Deadlines—these need to be in the mail
- 01/25 IRS efile system opens
- 02/10 Personal Property Exemption forms deadline
- 02/20 Personal Property forms deadline
- 02/28 State of MI Annual filing deadline
- 03/15 S-Corp 1120S and Partnership 1065 returns due
- 04/15 1040 Personal and 1120C Corporation due

# **Stimulus Payments**

First round Stimulus Monies received in 2020: We had quite the debate with Tax Class and
