New faces in our office



IRS Updates 2021

Refunds Delayed!

The IRS reports that over 8 million tax returns have not been processed and the backlog will continue until June 2022 according to their update. So 2020 may still be an issue for some of your tax refunds. Currently they report 16000 calls per IRS employee on the phone lines. And we have no short

cut to them (x)

IRS expects to **open** E-File Jan 24, 2022 (HEY this is really early for their standard) However all forms will not be available. Previous years will be open – so if we need to amend or file, we will have access..

Any tax payer filing an **Earned Income Credit** will have their REFUND **delayed** until they process all the credits

S-Corporaton Changes IRS and MI both weigh in

Some Basic Information: S-Corporation completes an 1120-S which generates a K-1 for income to flow through to your personal 1040

IRS adds new form:

IRS adds new form 7302 which will

attach to your personal return to show Basis in your S-Corp. This

form is designed to limit losses

from your S-Corp to your personal.

IRS says losses are passive and are

subject to passive loss limiations

Also passes legislation on 12-20-21 that gives the S-Corp new tax status with the State. Now you can optin to pay state tax from the corp bucket and take the write off on your personal

taxes. According to the State your State taxes paid by the corporation can transfer to Sch A without the \$10,000 cap limitation. This is a 2 year opt-in and according to your personal taxes may or may not be a good choice. Stay tuned for my advice on this



Reminders:

- Profit pass through to your personal.
- Reasonable Comp has to be considered.
- QBI Credit is still available for a deduction on your personal.
- Payroll (W-2 is still preferred)
- Retirement accounts can be setup to defer income.
- S-Election can be terminated for a standard Corp.
- ► However QBI still is not avail to Corps

From my Desk- Corp updates

After a painful learning curve, we have found that Owners who have a Company and pay rent on a building they also own need to establish a Triple Lease Rental agreement (this is the only lease agreement that has held up in tax court) A standard lease with CAM charges during Audit has been denied the CAM reimbursement. Please change these lease forms!

Other Company items:
the IRS is now concerned
about Note Payables To
and From owners.
Personal funds being used
in the business
Remember **Keep it Clean.**

NOW anything over \$25,000 requires a Promissory Note signed by the owner To or From the Corp. More Legal Stuff



Sch C you are not required since mixing funds is allowed on the personal taxes.

Minister Housing Allowance Challenged

Under I.R.C. 107, ordained, commissioned or licensed ministers may be able to exclude from income tax a housing allowance paid to the minister or the FMV or a parsonage that is provided to him or her in exchange for ministerial services.



IRS allowed housing allowances based on this case, it is recommended that the allowance be designated in writing by a resolution of the governing body, an employment contract, or a formally approved church budget

Court Challenge to Housing allowance in 2017, the federal district court for the Western Divstrict of Wisconsin held that the section 107 housing exclusion was unconstitutional on the grounds that it discriminates against secular employees and violates both the establishment clause of the First Amendment and the equal protection clause of the Fifth Amendment. Subsequently, the Seventh Circuit Court of Appeals overturned the district court ruling and found that the exclusion is constitutional [Gaylor V. Mnuchin, Case No 18-1277 & 18-1280 (7th Cir 2018)]

Student Loans?

Student loans IRS delays repayment till May 2022. Also IRS states that they will consider all the loan debt paid through out this period and all monies towards principle and interest forgiven from income. **YEAH** government pays student loans!

IRS opens portal on their website for tax payers

Wait I said no customer service.. well IRS is trying to give you online support. So a new portal to your tax records has become available for everyone.. Mentioned above that if you have a Child Tax Credit setting up this portal to get your forms may be the best way to get information

Q: Is Unemployment Taxable in 2021?

A: Currently this is TOTALLY taxable The forgiveness was for 2020

Just a side note that many of our Customers are still waiting for their federal refunds to come due to this change that the IRS said they would do.

Currently they are asking us to wait until June and if you haven't seen your refund we will be allowed to amend the return for you and send through efile. WOW we know...
